#### RADON

Recently, several homes in the subdivision have tested positive for radon gases.

Radon is a colorless, tasteless and chemically inert radioactive gas. It is formed by natural radioactive decay of uranium in rock, soil and water. It can be found in all 50 states. Unless you test for it, there is no way of telling how much is present.

You can obtain a home kit at your local home improvement stores, purchase online, or contact a home inspector.
